Chocolate Crazy – Conditions of Hire

Information

Chocolate Crazy supply for hire chocolate fountains larger than many for hire in WA and therefore often contain more chocolate; for instance our Montezuma chocolate fountain is 86 centimetres high and contains 7.00 kilos of chocolate to commence with and that is 50% more than some other suppliers for parties up to 100 people in size. So our prices are very competitive by comparison and you'll not have the embarrassment of having to purchase more chocolate for your guests half way through your party.

Prices

Customers/clients renting a chocolate fountain from Chocolate Crazy will be agreeing to the prices in the quotation plus any extra service that may have been agreed. However, prices are subject to revision and change from time to time. The price on your quotation will be the price you pay unless there any agreed additions for extra time or dipping food not on the original order and are charged later depending on availability etc. Clients may provide their own dipping products providing they are approved as suitable by Chocolate Crazy.

Reservations

We will make a reservation for a maximum of SEVEN DAYS at the end of which if a deposit is not received then the reservation will be deemed to have been cancelled. Quotations will be valid for FOUR WEEKS (28 days) only.

A Deposit of \$100.00 is required to book each chocolate fountain **and the balance must be paid 14 days prior to the date of the event.** Failure to pay the balance will mean the event is cancelled and the deposit not refunded. For corporate customers an Official Order must be provided and our terms are strictly Seven Days Nett for approved customers.

A Deposit will be refunded on cancellation providing FOURTEEN days notice has been given prior to the event date and has been received in writing or by email and only if the fountain has been re-rented out again at same time of the booked event.

Additional items, products or time not available or not known about at the time of invoicing shall be paid for in full by cash prior to the end of the event.

To Be Provided by the Hirer/Renter

Customers are advised that they must provide the following:

1. A sturdy table or bench capable of holding a weight in excess of 70 kilos with a minimum size of 75 X 120 centimetres.
2. Access to the required set-up area at least one and a half hours prior to the start time noted on the booking form.
3. Electrical power with socket to within one metre of the site of where the fountain will be placed.
4. A disposable plastic table cloth is not essential but it is highly recommended and we can supply one @ \$3.00.

Chocolate Crazy do have for hire depending on availability; tables, electrical cables and plastic table cloths, but unless requested at the time of order cannot guarantee to have these available. Prices are available on application.

Outside Use

We do not recommend that chocolate fountains are used outside for various reasons and these include constant temperature, drafts and insects unless adequate protection can be provided.

Image Rights

From time to time Chocolate Crazy may decide to update its web-site and brochures etc and reserves the right to use any images taken at any event for use in marketing and publicity.

Liability

Customers/clients the renters of property owned or supplied by Chocolate Crazy agrees to assume full responsibility and liability for any and all claims arising out of the use of the chocolate fountain and equipment or its fountain attendants. Chocolate Crazy will not be held liable for any injury, allergic reaction, loss or damage directly or consequently arising out of the use or rental of the chocolate fountain or any associated products or equipment. Clients/customers will indemnify Chocolate Crazy against and hold Chocolate Crazy harmless from all claims, proceedings, costs, damages and liability, including legal fees, arising out of, in connection with or resulting from the hire of fountains or equipment from Chocolate Crazy. Property hired or rented from Chocolate Crazy is not insured. All damages, loss breakages will be charged to the hirer/renter. The fountain and any other equipment provided by Chocolate Crazy is the responsibility of the hirer/renter until it is collected. Replacements will be charged at full present day values. It is the customers/clients the hirers of the fountains responsibility to ensure that Chocolate Crazy have reasonable access to set up the fountain for a function at the due time. *Delays will be charged at \$22.50 per half hour of delay. Chocolate Crazy shall be held harmless by the Client should in the very rare occasion that illness, injury, road traffic or any other situation beyond control of Chocolate Crazy that prevents Chocolate Crazy from completing the hire agreement.
